

## **Terms and Conditions for Pet-Friendly Accommodation**

### **General Information**

- Only dog-friendly hotel rooms are available; other pets are not currently permitted.
- Pet-friendly rooms are allocated on a first-come, first-served basis.
- Each Premier Room can accommodate up to two fully vaccinated dogs and four fully vaccinated dogs at Suite categories (weighing less than 20kg each).
- Pets must stay in designated pet-friendly rooms, which are specially prepared with a mat, food and water bowls, and towels for pet use. A "Pets Staying" plate must be hung outside the door at all times.

## **Guest Responsibilities**

- Be considerate of other guests. Limit noise caused by your pet and control their behavior. If noise or aggressive behavior is not manageable, we reserve the right to refuse accommodation, and the room rate will not be refunded.
- Pets with infectious diseases or fleas will not be accepted.
- Pets are not permitted to be left alone in the room at any time.

#### **Area Restrictions**

- Pets are not allowed in Siete Ocho, Jin Bo Law Sky Bar, or any food service areas. Pets are
  also prohibited from the swimming pool, gym, and function rooms. They may only access
  the lobby and your room.
- Pets must be muzzled and leashed at all times when outside your room. If your pet is
  persistently noisy, disruptive, or aggressive towards guests or staff, you will be asked to
  remove your pet from the premises.

#### **Additional Guidelines**

- If your pet is prone to urinating or defecating at will, you must carry a pet diaper to prevent accidents.
- The hotel does not assume any liability for your pet's actions while on the premises. You are liable for any damages caused by your pet, including the cost of repairs or replacements.
- Guests and dog owners will indemnify the hotel against all claims, liabilities, losses, and damages.



# 寵物入住守則

- 1. 酒店只限狗狗入住,目前尚未提供其他寵物友善房型。
- 2. 可攜帶寵物入住之客房數量有限,先到先得。
- 3. 每房只限最多 2 隻(普通房型)或4隻(套房房型)已完全接種疫苗的寵物犬入住(每隻少於 20 公斤)。
- 4. 寵物只能進出指定客房。客房內提供寵物墊、專用碗及專用毛巾等日用品於住宿期間使用。入住期間於房門需掛上「寵物入住中」掛牌。
- 5. 酒店無法接待太過神經質、吵鬧無法制止或有攻擊行為的寵物入住。「若上述情形嚴重影響到 其他房客,我方有權力拒絕您的住宿,房費將不作退還」
- 6. 酒店不接受帶有傳染病或跳蚤的寵物入住。
- 7. 請勿將寵物單獨留在房內。
- 8. Siete Ocho、Jin Bo Law Sky Bar 或任何其他提供餐飲服務的區域不允許攜帶寵物。禁止寵物進入游泳池、健身房和多功能廳。除酒店大堂和您的房間外,寵物不得進入酒店的任何樓層。
- 9. 寵物離開房間時需隨時繋繩及戴上口罩。主人需負責讓寵物保持安靜,若寵物持續發出噪音、 騷擾或攻擊房客或酒店人員、展現侵略性行為,酒店得要求寵物立即離開。
- 10. 若您的寵物有無定點大小便習慣,主人必須隨身攜帶寵物尿片,以免隨處便溺。
- 11. 寵物之行為必須由主人全權負責,酒店概不承擔任何責任。若寵物造成任何設施毀損、破壞或隨處便溺,本酒店可向顧客提出損害賠償要求,主人亦必須負擔後續維修及復原費用。
- 12. 客人及寵物主人將需就所有索償、責任、損失、損壞向酒店賠償。
